TEAM LEADER GIFT AID DECLARATION If possible, we would like the Team Leader to sign the Gift Aid declaration, as this simplifies administration.

Each walker is responsible for collecting their own sponsorship money, and forwarding it to the Team Leader.

Remember: 10 walkers each raising £25 will be enough to qualify as a 50/50 Group Entry (or 2 walkers each raising £125). However, 25 walkers each raising £10 **does not** qualify.

On arrival the Team Leader should hand in this form, followed by each walker with their individual sponsor forms (All forms will be returned at the end of the walk, so that sponsorship money can be collected).

When all the sponsorship money has been received by the TEAM LEADER, the TEAM LEADER will raise a cheque for 50% of the total amount received and forward it to the Wey and Arun trust together with your Sponsor Forms.

Gift Aid tax reclaim on the 50% retained by your organisation is the organisation's responsibility and not the Trust's.
