# for WACT volunteers - April 2018

#### Editorial

Just in case anybody missed it in Julian Morgan's monthly e-newsletter, there was some excitement in late March on the Loxwood Link navigable section. Between 19th and 29th March a large number of volunteers got the chance to pretend they were part of a real live Canal & River Trust workforce, by getting the chance to operate a hired amphibious machine. Following training by the contractors, Land & Water, and under the leadership of Loxwood Link Maintenance Manager Kev Baker, they helped remove large amounts of silt and reeds from the canal, and tidy up the vegetation along the towpath. This was all in preparation for the 2018 boating season, which began with a vengeance at Easter.

The WACT plant stable has grown yet again, following a generous donation which has allowed us to acquire a Yanmar mini-digger in good condition. Some of you who may have been around in the 1970s will remember the 'Teaspoon', that was attached to the back of the Trust tractor and helped clear sites such as Malham. Well, the name lives on in the new machine which will greatly ease the task of maintaining towpaths and other places inaccessible to larger machines.

The controversial plans to build some 1800 homes at Dunsfold Park has now been approved by the Secretary of State for Housing, Communities and Local Government. The site is bordered in part by the canal's summit level. Although WACT has, of necessity, remained neutral about the plans, the news should be positive for us. Homes beside water are highly desirable, particularly in this part of the country, so we hope the developers will be keen to make the most of the waterside location.

Finally, some dates. 21st April marks the Gennets Bridge Lock formal completion, and the Trust's Annual Meeting. 13th May is the River Arun small boat rally, and the 2018 Poddle sponsored walk will be held on 3rd June.

As anticipated in last month's  $\widetilde{\textit{WPN}}$ , we concentrated on finishing off at Malham lock on 5th March. We cleared all the brambles on the meadow side at the request of the landowner and added two more wires to the new fence making it stronger with four, rather than three, tensioned wires. The landowner was pleased with the result.

At Kev Baker's request we made our first visit to Gennets Bridge lock on the 12th and undertook a lot of hard work clearing both sides of the towpath north of the lock as far as the overspill weir. There was a lot of thickly grown brambles and low hanging tree branches which required a lot of effort to clear (see new photos on the Trust's website!).

You will not be surprised to hear that we didn't venture out the on the 19th following a revisit from the 'Beast from the East'. It was just too cold to work and the state of the roads was awful!

Thanks are due to Dave Evans who facilitated our visit to Sidney Wood in late March, with the result that we were able to complete the clearance of the towpath vegetation and overhanging branches all the way from lock 16 back to the second causeway from Firtree Copse, the point which we had reached after our visits in late November and early December. We also cleared both culverts 1 and 3. A really good day with favourable weather.

With Easter over, it is time to return to our regular sites.

## Northern (Summit) Working Party

My last report appears to be from the end of December last when the slipway site had just been inundated with water and we were talking about piled dams.

Well fortunately from a time and cost perspective this didn't happen and we were able to repair the breach with clay and pump out the workings. We have also been helped by the installation, by contractors, of a larger diameter culvert pipe under the road at the current Tickner's Crossing site. This enables water running off the airfield to escape into the river system and so far seems to be working well.

Conditions at the slipway have been harsh always too wet to move about and often too cold to lay bricks. However, we have made some progress. The bricklaying on the southern slipway wall has been completed and looks good with its coping bricks.

At the end of January, with help from NWPG, we poured the concrete for the northern wall and

subsequently dismantled the shuttering, ready for scaffolding to go up for more brickwork. In March, again with help from NWPG, we installed the oak timber wailings on the piled wharf to the south of the slipway. This was a difficult and time consuming task that involved drilling a large number of wide holes through the piles, fixing the timbers and then using the same timbers to pull the piles back into line. We have since positioned most of the steel work and timber back shuttering ready for when we can pour the concrete beam behind the piles. We shall need an improvement in the "Somme-like" conditions before we can complete this.

Down at the crossing, a small team have built a concrete bag surround to the inlet to the road culvert (mentioned earlier) which should hopefully direct any surplus water down the pipe rather than across the road. This is all part of the essential water control measures that we need in place before starting work on the new Tickner's Bridge.

Being winter, we have taken advantage of the conditions and felled a number of ash trees which were suffering from ash die back and have filled about 12 crane bags of logs for sale or use in the Trust's various log burners. When we really can't find alternative constructive work, we resort to tidying the site, containers and cleaning plant.

Looking ahead, we hope that better weather will enable us to substantially complete our work on the slipway by the end of May. This will lead into the NWPG Summer Camp in July where the work plan will soon be finalised. More details next time.

Please call, text or e-mail either myself or Dave Evans if you would like to help. We meet every third Saturday of the month and often on other Saturdays as required. Please note that for April, the third Saturday will in fact be the second Saturday (14th) due to a clash with the Trust AGM and Gennets Bridge Lock celebration on 21st April.
